- 1. RULES AND REGULATIONS.** Athlete agrees to obey all rules and regulations now enforced or prescribed in the future by Dennis White and his associated coaches. Athlete understands and agrees that Dennis White may revoke athlete's rights to participate because of failure to comply to the rules and regulations or due to any activity by athlete in using the facilities and services which create safety hazards or disrupts other athletes.
- 2. WAIVERS AND RELEASE.** You agree that the athlete assumes all risk of personal injury, death, property loss, or other damages that may relate to attending or participating in any of Dennis White's programs or activities. By assuming those risks you and the athlete waive, and release all claims you and your athlete may have or want to assert against Dennis White and his staff for any such personal injuries, death, property loss, or other damages concerned connecting to or arising out of any of the aforementioned risks. You release Dennis White from all claims, damages, demands, rights of action, causes of action, and liabilities, present or future, known or unknown, anticipated or unanticipated, resulting from or arising out of the athlete's attendance of or participation in activities, programs, or events, including, without limitation, those arising from his negligence or that of any other staff member.
- 3. DAMAGE.** You are liable for any damages you cause to equipment or property on the premises.
- 4. ATHLETE(S) PHYSICAL FITNESS.** You represent that the athlete is physically fit to engage in activities in which he or she participates in. You are solely responsible for all the health risks associated with those activities.
- 5. MISCELLANEOUS.** This, Rules, Regulations, and Liability Waiver and the Athlete Agreement constitute the entire and exclusive agreement between the parties. Any promised, representations, understandings and/or agreements pertaining directly or indirectly to this Rules, Regulations and Liability Waiver, and the Client Agreement, which are not contained herein, are hereby waived. Only an instrument in writing may modify this Rules, Regulations and Liability Waiver, and Client Agreement; however, Seller or assignee of this Rules, Regulations and Liability Waiver and the Athlete Agreement is hereby authorized to correct patent errors in the Rules, Regulations and Liability Waiver and the Client Agreement (and in other documents, if any, executed connection herewith). At Seller's option, this Rules, Regulations and Liability Waiver and the Client Agreement shall be null and void if Seller's employee in accordance with Seller's then-current price and payment programs does not complete it. No change to any printed term in our Rules, Regulations, and Liability Waiver and Client Agreement is invalid, the same shall not affect the other provisions hereof.
